

# **Privacy Policy**

#### 1. Introduction

This Privacy Policy explains how **HK Data Solutions (Pty) Ltd (Registration No. 2016/352497/07)**, trading as **Dev Rocket** ("we," "us," "our"), collects, processes, stores, and protects personal information in accordance with the **Protection of Personal Information Act (POPIA)** and applicable international privacy laws such as **GDPR**.

By using our services, you ("Client," "you," "your") agree to the collection and processing of your personal information as outlined in this policy.

#### 2. Information We Collect

We collect and process the following types of personal information:

#### 2.1 Information You Provide to Us

- Full Name
- Company Name (if applicable)
- Email Address
- Contact Number
- Physical and Billing Address
- Payment Information (we do **not** store credit/debit card details; payments are processed via secure third-party payment gateways)
- Domain Registration Details

### 2.2 Automatically Collected Information

- IP Address
- Browser Type & Version
- Operating System
- Referring URLs
- Website Usage Data (e.g., pages visited, time spent on site)

#### 2.3 Cookies and Tracking Technologies

- We use **cookies** and similar technologies to enhance website functionality and improve user experience.
- You can manage cookie preferences through your browser settings.

# 3. How We Use Your Information

We process personal information for the following purposes:

1. **To Provide Our Services** – Domain registration, website hosting, email services, and customer support.



- 2. To Manage Client Accounts Billing, invoicing, and account security.
- 3. **To Communicate with You** Service updates, policy changes, or marketing (with consent).
- 4. To Improve Our Services Website analytics and service enhancements.
- 5. **To Comply with Legal Obligations** As required by South African law and international regulations.

# 4. Sharing of Personal Information

We do **not** sell or rent personal information. However, we may share information under the following circumstances:

- With Domain Registrars & Regulatory Bodies (for domain name registration and compliance).
- With Third-Party Service Providers (for payment processing, email hosting, and security).
- If Required by Law (to comply with legal obligations, court orders, or law enforcement requests).

# 5. Data Protection & Security

We implement technical and organizational measures to protect your personal information, including:

- Secure **SSL encryption** for data transmission.
- Access control to restrict unauthorized access.
- Regular security audits and firewall protections.

However, no method of transmission over the internet is 100% secure, and we cannot guarantee absolute security.

### 6. Your Rights Under POPIA

As per **POPIA**, you have the following rights:

- 1. **Right to Access** Request details of personal data we hold about you.
- 2. Right to Correction Request correction of inaccurate or outdated personal data.
- 3. **Right to Deletion** Request deletion of personal data no longer necessary for its original purpose.
- 4. **Right to Object to Processing** Object to the use of your data for direct marketing.
- 5. Right to Withdraw Consent Withdraw consent where processing is based on consent.
- 6. **Right to Lodge a Complaint** Submit complaints to the **Information Regulator of South Africa** if you believe your data rights are being violated.
